



**ChiaSWIM**  
**Race Regulation**  
**Distances: 1.9km-3.8km-5km**

The 5th edition of the ChiaSWIM Sardinia is organized by Laguna Running S.S.D.R.L. It will take place on the beach of Su Giudeu, near Chia Laguna Resort on April 25th 2024.

**ENTRY REQUIREMENTS:**

- all members and not members athletes. It is also mandatory to report the use of any medications and/or allergies. For the 5km and 3,8km distance, a medical certificate for competitive swimming or triathlon is compulsory.

The organizing company cannot be held liable for any consequences of damage to property or persons occurring before, during and after the event.

Competitors may use masks, goggles, nose plugs but not snorkels, respirators and fins. At the end of the race, the chip must be returned in the designated area.

Any withdrawal from the competition must be reported to the Jury.

**REGISTRATIONS AND ENTRY FEE:**

**Registrations** will be online and you can register at [www.followyourpassion.it](http://www.followyourpassion.it)

**Fees:**

- 1.9 km distance: 20,00 €
- 3.8 km distance: 30,00 €
- 5 km distance: 35,00 €

Fees are exclusive of secretarial fees, which will be calculated at the time of registration.

**Timing**

The timing and processing of the rankings will be carried out using a system based on an active transponder (CHIP) which will be handed out when collecting the welcome pack. The device must be worn for the duration of the event on the ankle.

The chip must be handed in at the finish of the race. Athletes who have not started or have withdrawn must also hand in their Chip in the same logistics area near the finish line. **Failure to return the chip will result in a charge of € 40.00.**

**Online registration will be closed at midnight on Monday 22 April 2024.**

After that date, registrations will only be available at the race office, which will be set up at the Chia Laguna Resort on 25/04 from 07:30 to 09:00



On these days it will also be possible to collect the race bib package.

Race package: gadget of the event, numbered swimming cap (only one that can be used during the race), water, finisher medal.

### **Registration transfers and change**

Athletes who have already registered but are unable to take part in the race have the opportunity to transfer their registration to another athlete who meets the participation requirements of these regulations. This can be done independently via the dashboard. The registered athlete, once in the registration dashboard, has to click on "TRANSFER REGISTRATION" and enter the email of the person to whom you want to transfer the registration. The person will receive an email with a link to enter all personal data and proceed with the payment of 7€ for the transfer handling fee. The name change can be done until Wednesday 10 April 2024

It is also possible to change the race by transferring the registration already made to a different distance. In this case, any surcharge on the registration fee must be paid when collecting the bib. Differences in entry fees will not be reimbursed.

A change of race/distance must be requested by Wednesday 10 April 2024 at [info@followyourpassion.it](mailto:info@followyourpassion.it) and will incur a charge of €7 for transfer handling costs in addition to the difference in fee.

### **RACE SCHEDULE:**

#### **For all distances:**

- 07:00-8:30: registrations and race bib collection
- 09:00: Technical meeting
- 09:30: start of races (all distances)
- Award ceremony at the end of the event at Chia Laguna Resort

### **AWARDS CEREMONY:**

There will be prizes in kind for the first three finishers of the 1.9km-3.8km-5km distances

### **GENERAL INFORMATIONS:**

There will be 1600 m2 of beach available and all participants are invited to collaborate to keep it clean and avoid waste.

*RELEASE, WAIVER OF LIABILITY AND AUTHORIZATION: "I declare under penalty of perjury (art. 26 l. 15/68 and art. 489 c.p.) that: I have read and understood the CHIASWIM' race rules; I recognize that participation in the event is a potentially hazardous activity and I willingly assume all risks associated with such participation; I am aware that in registering to the event I must provide a valid medical certificate where required. I declare that I voluntarily registered, that I assume all risks arising from my participation in the event, that I am familiar with the characteristics of the event and that I am in adequate mental and physical condition for participation, that I assume all*



*risks arising from my participation including falls, contact with other participants, spectators or others, weather conditions, including scorching heat, extreme cold and/or wet weather, any type of risk well known and assessed by me.*

*Having read this waiver and knowing these facts, and in consideration of your acceptance of my application for the CHLASWIM, I, for myself and anyone entitled to act on my behalf, waive and release Laguna Running SSDrl, MG Sport srl, the Chia Laguna Resort, IHC Spa, Comune di Domus De Maria, Provincia del Sud Sardegna, Regione Sardegna, other partners, sponsors and their representatives, successors, shareholders, directors, officers and employees of the foregoing entities, from present and future claims and liabilities of any kind, known or unknown, arising out of my participation in the event.*

*I understand that the CHLASWIM entry fee is not refundable, not even in the event of the race cancellation or postponement, or due to any reason that cannot be attributed to the organizers, including revocation by public authorities.*

*In registering to the event, I agree to allow my photo, video or film likeness to be used for any legitimate purpose by organizers, sponsors and assigns.*

*I certify that I have read the privacy document available on the official website [www.followyourpassion.it](http://www.followyourpassion.it) and I that I have given consent to the use of personal data. Collected data will only be used for the purpose provided in the privacy document above, available on [www.followyourpassion.it](http://www.followyourpassion.it)".*

### **Privacy and Image Rights**

By subscribing to "ChiaSWIM", the athlete expressly authorizes the Organizer together with legal entities with whom it has professional and business reports and associated with taking the pictures of the event, the acquisition of the free right to use still or moving images on which I will appear, taken at of their tenders of all visual media as well as promotional materials and / or advertising products and spread throughout the world and for the maximum time allowed by the laws, regulations, treaties in force, including the extension options to be made to the period provided.

### **Failure to Carry**

If the race is cancelled and / or postponed to another date, or in any case, do not turn to force majeure and / or reasons beyond and / or not related to the will of the Organization, including the withdrawal of the performance by the competent public authorities, the registered athlete will have nothing to expect from the Organizing Committee and / or Laguna Running SSDRL and MG Sport Srl, nor for the return of the registration fee, or as reimbursement of any expenses incurred or to sustain. The submission of the application form has the value of acceptance of this clause and expressly renounces any claim resulting in the cancellation and / or postponement of the race.

**Final Warning:** the Organizing Committee reserves the right to modify these rules at any time for reasons it deems appropriate for a better organization of the race. The event will take place with any atmospheric condition.
